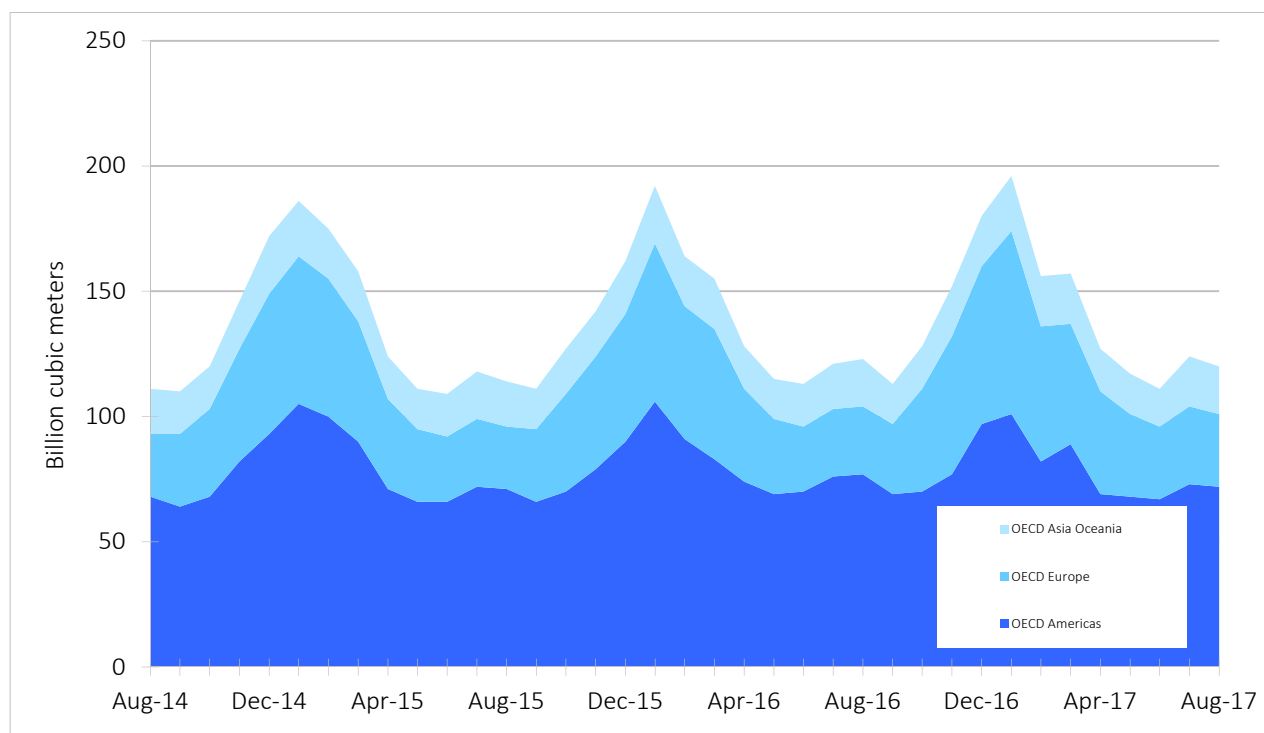

CHART 1

Gross consumption of natural gas by OECD region



OECD indigenous production of natural gas was 4.0% higher in August 2017 compared to August 2016. The increase was led by OECD Asia Oceania (+21.6% y-o-y¹), where Australian production increased by 24.2% y-o-y. OECD Europe's growth (+7.1% y-o-y) was driven by Norway (+27.9% y-o-y), where fields under maintenance in August 2016 are now online and the new Byrding field was brought into production. OECD Americas' growth (+1.3% y-o-y) was led by the USA (+1.6% y-o-y) and Canada (+3.5% y-o-y). Overall, indigenous production of natural gas remained relatively constant (+0.3% y-t-d²) in the first eight months of 2017 compared to the same period last year.

Total OECD imports (entries³) of natural gas increased by 9.8% in August 2017 compared to August 2016, where the growth was driven by OECD Europe (+17.8 % y-o-y). Imports decreased modestly in OECD Asia Oceania (-0.5 % y-o-y) and the OECD Americas experienced a 12.3% y-o-y decrease, particularly reflecting reduced Mexican imports (-34.3% y-o-y). Overall, total OECD imports of natural gas increased in the first eight months of 2017 compared to the same period last year (+7.4% y-t-d).

Total OECD exports (exits³) of natural gas increased by 12.7% in August 2017 compared to August 2016, bolstered by growth across all OECD regions. The rise was led by OECD Asia Oceania, where exports in August 2017 increased by 28.4% y-o-y, particularly from Australia. The increase in exports from the OECD Americas (+5.1% y-o-y) was led by the US (+15.3% y-o-y) driven by LNG exports. Overall, total OECD exports of natural gas increased in the first eight months of 2017 compared to the same period last year (+11.3% y-t-d).

Total OECD gross consumption of natural gas decreased by 2.9% in August 2017 compared to August 2016. OECD Europe experienced a 6.8% y-o-y growth whilst OECD Asia Oceania experienced a 0.8% y-o-y decline. The OECD America's decline (-6.8% y-o-y) was led by Mexico (-22.4% y-o-y) primarily due to lower deliveries to power generation. Overall, total OECD gross consumption of natural gas decreased slightly in the first eight months of 2017 compared to the same period last year (-0.5% y-t-d).

Indigenous production of natural gas by OECD region

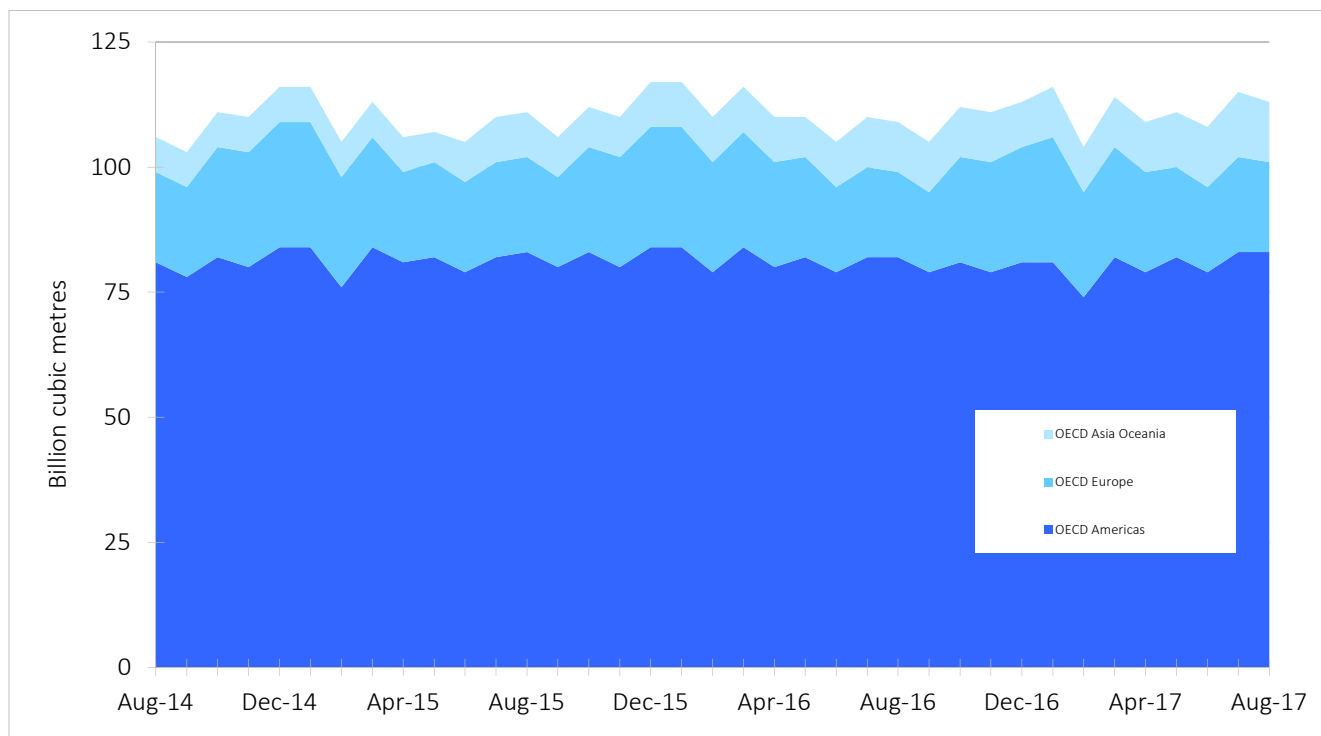
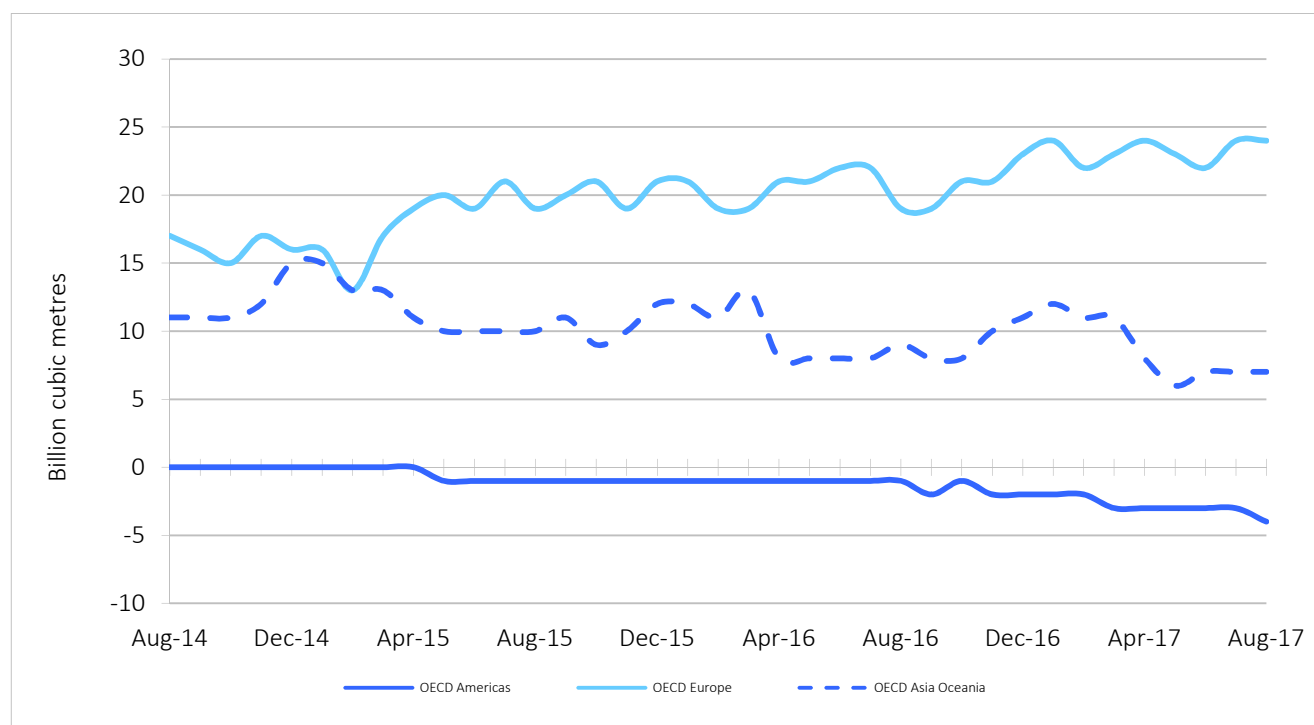

2) COUNTRY NOTES

Belgium	Most recent data on origins of imports and final destinations of exports of LNG are the best estimates from the Belgian Administration based on available preliminary data.
Canada	Data for Canada are submitted by the Department of Natural Resources (Natural Resources Canada, or NRCan), based on actual and preliminary data from Canada's national statistical agency (Statistics Canada) and various other sources. In cases where data from these sources are unavailable, estimates are conducted by NRCan, based on information available at the time, including alternative sources. Data are usually finalised within three months of the first publication. An important source for any differences between data published by Statistics Canada and data published by the IEA is data estimated by NRCan or the IEA Secretariat.
Iceland	There is no natural gas data for Iceland, as there is neither production nor consumption.
Ireland	As of April 2017 there is no gas stored in Ireland. Stock figures for April-May 2017 refer to line pack gas.
Israel	The statistical data for Israel are supplied by and under the responsibility of the relevant Israeli authorities. The use of such data by the OECD is without prejudice to the status of the Golan Heights, East Jerusalem and Israeli settlements in the West Bank under the terms of international law. Information is based on data published by the Ministry of Energy and Water Resources as well as the Central Bureau of Statistics.
Mexico	Observed gross inland deliveries of natural gas from January 2013 onwards are estimated. Revisions are pending.
