



CHART 1

Indigenous production of crude oil, NGL and feedstocks by OECD Region



Total OECD production of crude oil, NGL, and refinery feedstocks increased by 4.3% in October 2017 compared to October 2016. This growth was driven by the OECD Americas (+5.4% y-o-y¹) where the United States' production grew by 10.2% year-on-year despite the impacts of tropical storm Nate on offshore production. Production decreased in both OECD Asia Oceania and OECD Europe by 8.4% and 0.4% year-on-year, respectively. Overall, total OECD production grew by 2.1% in October on a year-to-date² basis.



Total OECD refinery gross output of total products grew by 3.3% in October 2017 compared to October 2016. Growth was experienced in all OECD regions led by the OECD Americas (+3.9% y-o-y), where the United States' post hurricane recovery efforts led to higher production than a year earlier. OECD Asia Oceania and OECD Europe experienced growth of 5.3% and 1.4% year-on-year, respectively. Overall, total OECD refinery gross output of total products grew by 1.3% year-to-date in 2017.

Total OECD net deliveries of total products grew by 1.7% in October 2017 compared to October 2016 and showed growth on a year-to-date basis (+1.2%). The OECD Americas led growth in physical terms, with an increase of 1.5% year-on-year followed closely by OECD Europe (+2.2% y-o-y). OECD Asia Oceania's growth (+1.2% y-o-y) was built on growth in naphtha (+14.1% y-o-y) and Kerosene (+12.0% y-o-y).

Total OECD stock levels of total oil on national territory decreased by 6721kt in October 2017 compared to September 2017 and closed at 542 million metric tons. This trend was driven by drawdown of total oil inventory in the OECD Americas, specifically the United States (-4711kt) which experienced higher refining activity after Hurricane Harvey and Nate. In OECD Asia Oceania, the significant stock build of secondary products (1221kt) offset the large stock draw of primary products (-1287kt). While in OECD Europe, total oil stock levels dropped by 2103kt during October 2017 mainly due to high stock draws of middle distillates in the majority of European countries.

2) COUNTRY NOTES

Australia	Starting from January 2017 gas/diesel oil and motor gasoline closing stock data reflect the inclusion of new companies in the Australian data collection system.
Austria	Most recent data are the best estimates from the Austrian national administration, based on available preliminary data. Data are usually finalised within three months following the first publication.
Canada	<p>There is a break in series between December 2015 and January 2016 data as the Canadian Administration is using a new methodology from January 2016 data onwards. Under the new methodology crude oil includes condensates and pentanes plus for all flows and motor gasoline imports are better accounted for.</p> <p>Furthermore, reporting has been improved with an appropriate use of the flow recycled products. Revisions to historical data are pending.</p> <p>Data for Canada are submitted by the Department of Natural Resources (Natural Resources Canada, or NRCan), based on actual and preliminary data from Canada's national statistical agency (Statistics Canada) and various other sources. In cases where data from these sources are unavailable, estimates are conducted by NRCan, based on information available at the time, including alternative sources. Data are usually finalised within three months of the first publication. An important source for any differences between data published by Statistics Canada and data published by the IEA is data estimated by NRCan or the IEA Secretariat.</p>

- United States Following a methodological change in the US Energy Information Administration (EIA) reporting, industry stocks of crude oil for the United States exclude crude oil lease stocks (crude oil stocks held at producing sites) beginning with data for January 2005.
