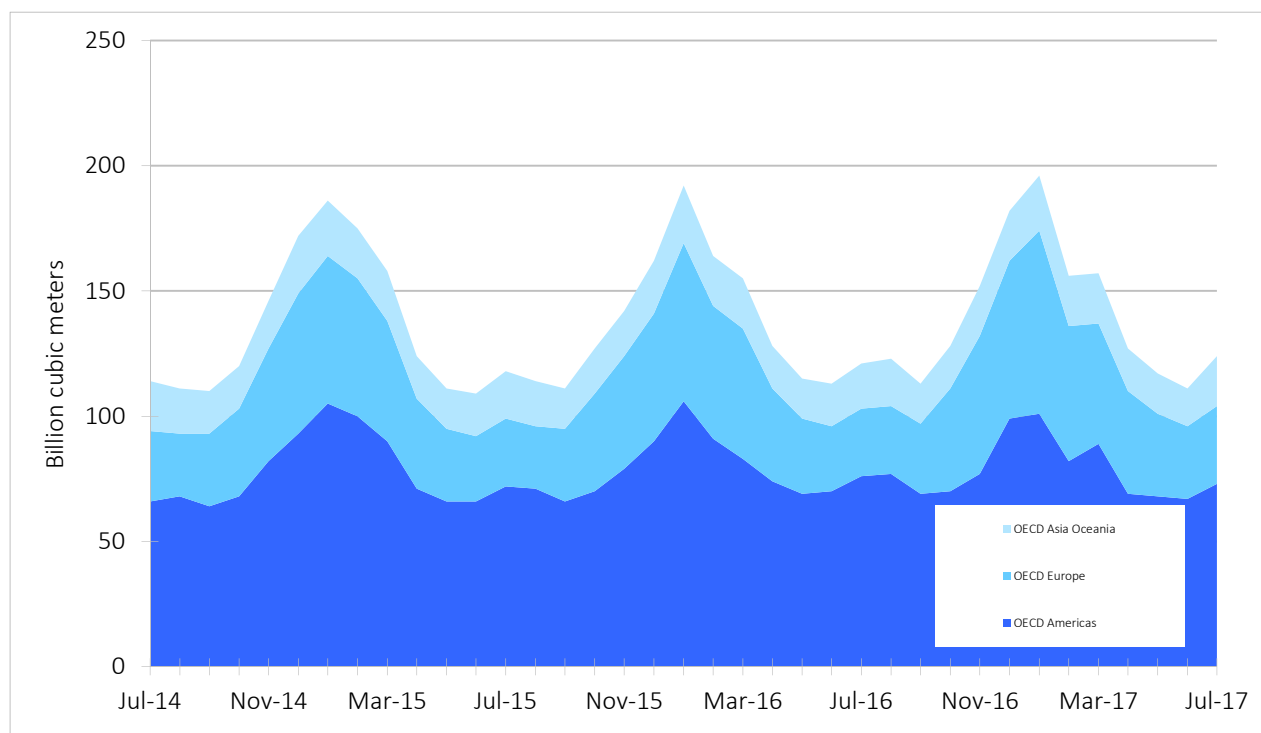

CHART 1

Gross consumption of natural gas by OECD region



OECD indigenous production of natural gas increased by 3.6% in July 2017 compared to July 2016. The increase in production was driven by OECD Asia Oceania (+28.4% y-o-y¹), where production in Australia continued to be high due to above nameplate capacity production at the Australia Pacific LNG project. OECD Europe and the OECD Americas experienced marginal increases in indigenous production in July 2017 compared to July 2016, increasing by 2.7% and 0.8% year-on-year respectively. Overall, indigenous production of natural gas remained broadly unchanged (-0.2% y-t-d²) in the first seven months of 2017 compared to the same period last year.

Total OECD imports (entries)³ of natural gas increased by 5.1% in July 2017 compared to July 2016, driven by growth in OECD Europe (+5.7 % y-o-y) and OECD Asia Oceania (+12.0% y-o-y) respectively. Within OECD Europe, imports strongly increased in Turkey (+28.4% y-o-y), while growth in OECD Asia Oceania was driven by Korea (+45.4% y-o-y). Increased imports to Korea reflect the start of a 20-year supply agreement for US LNG at the end of June 2017.

Total OECD exports (exits)³ of natural gas increased by 11.2% in the first seven months of 2017 compared to the same period last year, bolstered by growth across all OECD regions. The rise was led by OECD Asia Oceania, where exports in July 2017 increased by 37.5% y-t-d, due to high exports from Australia. The increase in exports from the OECD Americas (+20.3% y-t-d) was led by the US, where exports increased by 42.5% year-to-date, and are already greater than they were in the whole of 2015.

Total OECD gross consumption of natural gas grew by 1.9% in July 2017 compared to July 2016. Growth in OECD Europe (+14.8% y-o-y) and OECD Asia Oceania (+7.3% y-o-y) was slightly countered by the OECD Americas, where consumption fell by 4.0% y-o-y. Overall, total OECD gross consumption of natural gas decreased marginally in the first seven months of 2017 compared to the same period last year (-0.2% y-t-d).

Indigenous production of natural gas by OECD region

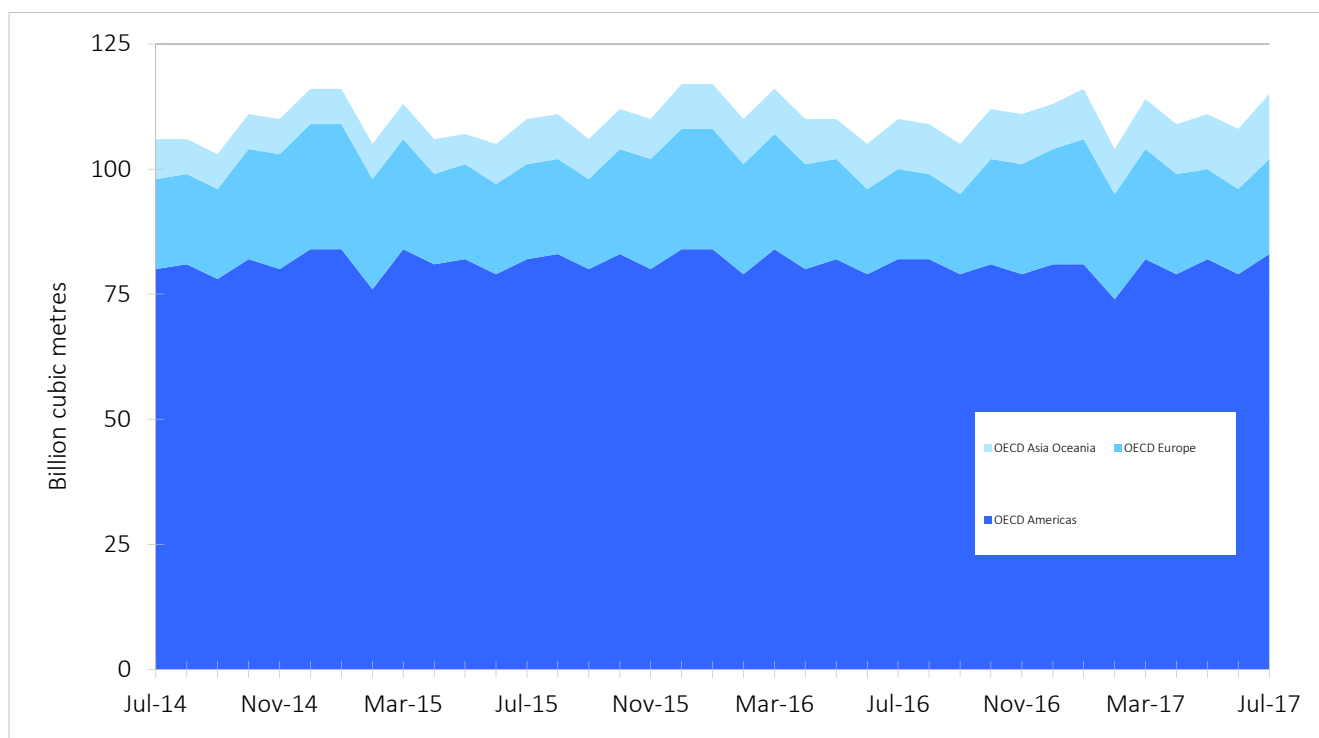
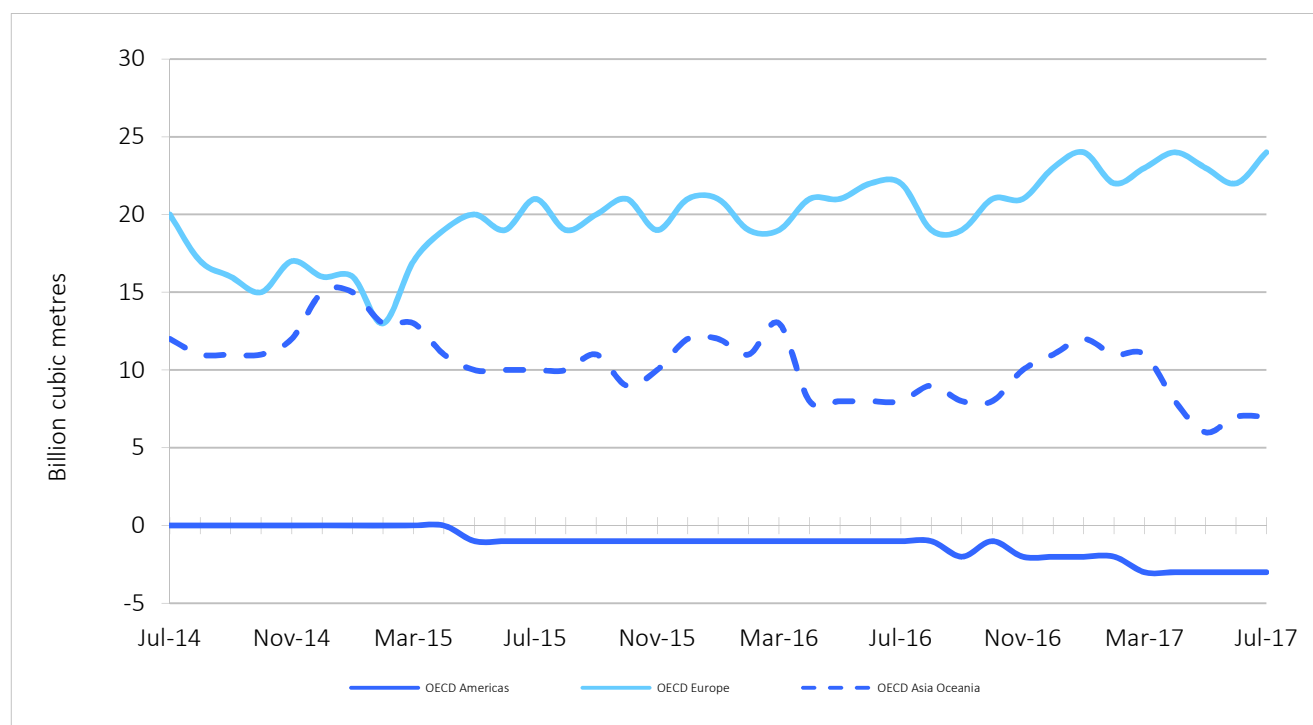

2) COUNTRY NOTES

Belgium	Most recent data on origins of imports and final destinations of exports of LNG are the best estimates from the Belgian Administration based on available preliminary data.
Canada	There is a break in stocks for natural gas between December 2015 and January 2016. From January 2016 data onwards Statistics Canada is officially publishing data on stock levels. Data for Canada are submitted by the Department of Natural Resources (Natural Resources Canada, or NRCan), based on actual and preliminary data from Canada's national statistical agency (Statistics Canada) and various other sources. In cases where data from these sources are unavailable, estimates are conducted by NRCan, based on information available at the time, including alternative sources. Data are usually finalised within three months of the first publication. An important source for any differences between data published by Statistics Canada and data published by the IEA is data estimated by NRCan or the IEA Secretariat.
Iceland	There is no natural gas data for Iceland, as there is neither production nor consumption.
Israel	The statistical data for Israel are supplied by and under the responsibility of the relevant Israeli authorities. The use of such data by the OECD is without prejudice to the status of the Golan Heights, East Jerusalem and Israeli settlements in the West Bank under the terms of international law. Information is based on data published by the Ministry of Energy and Water Resources as well as the Central Bureau of Statistics.
